## Non-Fungible Tokens (NFTs)

Non-Fungible Tokens (NFTs) are unique digital assets that represent ownership or proof of authenticity of a specific item or piece of content, using blockchain technology. Unlike cryptocurrencies like Bitcoin or Ethereum, which are fungible (meaning one unit is interchangeable with another), NFTs are non-fungible, meaning each token has a distinct value and cannot be exchanged on a one-to-one basis with any other token.

In early March 2021, a group of NFTs by digital artist Beeple sold for over \$69 million. The sale set a precedent and record for the most expensive digital art sold at the time. The artwork was a collage comprised of Beeple's first 5,000 days of work.
